Following the Operation and Maintenance portion of the budget, the proposed Capital Projects for 2015 was then reviewed. This draft included the suggested changes from April 8<sup>th</sup> as well.

Several questions were asked by Council regarding the priorities of the proposed capital projects.

A discussion ensured pertaining to the proposed renovations to the former Service Ontario building in order to accommodate the Community Policing Office as well as potentially public washrooms and meeting space. The CBO is working on an preliminary cost estimate for the draft proposed capital projects for consideration.

CAO, Marsha Paley, suggested that the OPP be invited to the next Council Meeting to provide clarification as to their requirements within a new location. Council concurred with this suggestion to invite the OPP to the May 6<sup>th</sup> council meeting.

The overall impact to the municipal tax rate over 2014 is approximately a 2% increase as the budget now stands.
