#### 7. DEPARTMENTAL REPORTS

#### a. <u>Director of Emergency and Safety Services/Fire Chief, William Davidson</u>

The report provided highlights on various activities that were undertaken in the month of February 2018 for Emergency and Safety Services in the areas of Health and Safety, Fire Service and Emergency Management.

Councillor Cornelissen inquired as to the emergency warning notification system that North Middlesex residents would have access to in the event of a potential tornado.

Chief Davidson responded that there are three options available to the residents:

- 211 system (resident would call in to hear available notifications)
- Ontario Emergency Public Warning notifications ie: Individuals sign up on their own to receive this updates on their devices such as IPhone, IPads etc.
- If North Middlesex declared an Emergency, the Emergency Information Officer would send out Media Releases on behalf of Municipality

#### b. Clerk – Use of Corporate Resources Policy during an election year

The policy is a mandatory under the Municipal Election Act, 1996, as amended. The purpose of the policy is to provide a consistent approach for candidates during an election year. It ensures accountable and transparent election practices regarding the use of corporate resources during an election campaign.

That this policy be hereby adopted for use by Candidates commencing with the 2018 Municipal Election.

Clerk – Appointment of Compliance Audit Committee for Municipal Election

The report outlined the statutory requirement under the Municipal Election Act, 1996, as amended, Section 88.37 (1) that states each municipality must appoint a Compliance Audit Committee no later than October 1, 2018. The purpose of the committee is to consider a compliance audit application received from an elector that a candidate or a registered third party has contravened provisions of the MEA relating to election campaign finances.

- 1. That the appointment of Compliance Audit Committee Report, prepared by the Clerk dated April 4, 2018 concerning the appointment of a Compliance Audit Committee be received for information;

That the following citizens be appointed by By-Law, to sit on the Compliance Audit Committee for the Municipality of North Middlesex: Andrew Wright, Christene Scrimgeour and Dan Ross, for the term commencing December 1, 2018 to November 14,2022; noting that the by-law will include the Terms of Reference for the Compliance Audit Committee; and
- 3. That the Members of the Compliance Audit Committee be compensated \$100.00 per meeting, plus mileage, as identified in the Terms of Reference for the Compliance Audit Committee.
