7:00 p.m. - Carol Lindsay, owner of Okiok Siberian Husky Kennel attended council regarding concerns she had relating to enforcement and licencing of dog kennels. She advised according to the municipal by-law, kennels breeding registered dogs only should be licenced and she is the only one who is breeding registered dogs. There are other individuals obtaining kennel licences in North Middlesex that are not run according to the regulations. Ms. Lindsay stated that she has concerns with kennels being puppy mills. She stated that she brought this to the By-law Officer's attention last year however nothing has been done to date. Recently she reported another puppy mill and the CAO advised the By-law Officer to contact SPCA which was done, however, no action was taken by them. She suggested that new by-laws need to be written and that she should be hired to investigate and inspect kennels. She also advised that the SPCA has no objection to outside inspectors. Council thanked Ms. Lindsay for the information and will have staff review the current by-law and make recommendations to council on any proposed changes.

7:45 p.m. – Alice Bruce – North Middlesex Community Medical Centre attended Council to update them on the recruitment efforts in the last few months. A recruitment firm was hired and development of their website is also underway. Mrs. Bruce then made a request for financial support for the following: Web Development \$2,200.00, Physician Recruitment Firm \$7,800.00 and contribution for placement fee for two doctors matching funds with NMCMC of up to \$25,000.
