7:00 p.m. – Presentation by D'Arcy Elliot and Tony Commissio from MacLachlan/HMS Insurance & Financial Services of the 2014 Insurance Program.

Highlights of the increases within the premium were reviewed. The General Liability area is seeing the largest increase which is due to the amount of claims against municipalities in recent years. Some other enhancements to the policy include a legal expense program and a new tool available to Road Supervisors only called "Snowman Access" which tracks and records exactly when the weather reports are viewed which is mandatory to occur three times per shift. This also provides further documentation of what actions taken as well from the Supervisor. Various questions were asked by Council regarding the premium increase which represents a 9.9% increase. The representatives were thanked for attending the meeting.

 a) Report from Drainage Superintendent – Hooydonck/Hendrikx Municipal Drain Abandonment

Drainage Superintendent, Glen Bullock and Armin Kruspel, Spriet Associates updated Council further to his initial report that this request for abandonment was signed by all landowners with the exception of the Roads Dept. Two municipal roads are assessed to this drain (Haskett Road and Bornish Drive). Council expressed concern with possible implications to our roads and the fact the no agreement would be place to allocate costs. Clerk Jackie Tiedeman added that in consultation with the Drainage Superintendent, this was the first request of abandonment of a municipal drain that the municipality has had to deal with. As staff we try to be as expedient as possible in processing drainage requests however we need to be sure the best interests of the municipality are being taken into account. Additional information was obtained in consultation with OMAFRA today due to the fact that this drain had a previous request for maintenance work under Section 78 and a provisional by-law was given first and second reading at the November 18th meeting. As well, costs were expended for this project and needs to be recouped. If Council agrees to abandon this municipal drain, we want ensure that costs are recouped and the provisional by-law dealt with appropriately.

The following amended recommendation was brought forth and approved.

CORNELISSEN/MCLINCHEY: That Council approves the abandonment of the Hooydonck-Hendrikx Municipal Drain under By-law #81 of 2013. That all costs associated with the Section 78 report is paid in full to the municipality at which time By-law #69 of 2013 be terminated.
