6. DELEGATION

Ja'Nell Brenner – Citizen Comments

Ms. Brenner presented her letter in person and Council thanked her for this insight.

b. Bill Pigram, Manager of Community Employment Choices

Mr. Pigram attended Council to provide an overview of his services in Middlesex County that assist individuals who have suffered job loss or who are in employment transition. Also, they provide a variety of services to businesses that are growing their work forces. Their main office is located in Strathroy but they serve itinerant service in Parkhill, Lucan, Dorchester and Glencoe.

Several questions were asked by council members and responded to by Mr. Pigram. Council thanked him for his presentation.

7. DEPARTMENTAL REPORTS

a. Report from Infrastructure and Operations – Status of the 806589 Ontario Ltd. Subdivision.

An overview of the report was provided by Planner Barb Rosser and Director of Infrastructure and Operations Jonathon Graham. An update was also provided regarding the development of the lot at 298 Hastings Street. Staff advised that as long as servicing is available there would be no planning issues to prevent a building permit. Mrs. Merritt, who was in attendance, was advised to seek legal input in order to verify status of lot conveyance.

c.Report from Administration – Preliminary 2017 Capital Budget

Several questions were asked by Council as to how the suggested projects were prioritized. Staff responded that the information was compiled through consultations with departmental managers, the Director of Infrastructure, the Middlesex IT department and review of the 2016-2019 Capital Plans. The preliminary 2017 Capital Budget with forecasts for the years 2018-2019 is subject to change upon the review of the upcoming comprehensive Asset Management Plan, the bridge and culvert inspections reports and the 2016-2021 and Beyond Strategic Plan. An updated Capital Budget and five year forecast will be presented in early 2017.

h.Report from Administration – Fees and Charges By-law

Clerk, Jackie Tiedeman, provided an overview of the proposed changes as a result of the review.

As a result of the review the following motion was brought forward:

MOTION #412/16

NICHOL/MCLINCHEY: That reference to the "or current MTO published rates" be removed from Section 9.3 Open Air Burn Violations: 1st Offence and 2nd and subsequent Offences;

And that the fee for an Open Air Burn Violation be a flat fee and not based on the number of vehicles on site.

Councillor Nichol requested clarification as to the number of emergency vehicles that attend this type of call.

Also, it was noted in the report that staff will send a letter to the property owner advising of the violation. A copy of the letter will be tracked by owner should a further violation occur and invoiced accordingly.

Council also requested clarification on Section 3 Building Department, Section 3.34 "No permit prior to commencing construction or demolition or changing use shall pay an additional fee equal to 100% of the amount calculated as regular permit fee up to a maximum of \$2,000.00" as to whether this was a mandatory fee under the *Building Code Act*.

Staff will provide an update on December 21, 2016 prior to consideration of the By-law.

And that staff be directed to finalize the By-law with amendments as noted for consideration on December 21, with an implementation date of January 1, 2017 unless otherwise noted in the By-law.

And further that following the 45 day public review and comment period, a report containing any comments received, along with a further revised by-law, if necessary, will be brought forward for Council's consideration.

Councillor Nichol requested Council to defer any decision on the \$30,000 that was earmarked as a donation towards a new Food Bank Building. As this time, the Board is in the process of drawing up plans that would open up the food bank space and improve use of the current building and this will include quotes on the required upgrades to the building as well as a business plan.

Deputy Mayor Ropp also wished to pass along congratulations to Mayor Shipway on being elected as Warden of Middlesex County for 2017.

Deputy Mayor Ropp updated Council on the following matters from County Council:

Planning Services will be part of the County Levy; Study on cyclists on County Roads; SWIFT – update status - separate governing Board Councillor Cornelissen questioned that status of the motion that was sent to the County regarding roundabouts at two intersections in North Middlesex.

Deputy Mayor Ropp clarified that the roundabouts in the neighbouring municipalities are located on MTO Roads. There has been discussion only at this point regarding the need for a study, short term improvements including rumble strips, larger stop signs with a light on top and the removal of the overhead hanging light. OPP reports are being reviewed as to accidents/fatalities at these intersections. A full report will be prepared and considered by County Council.
