b. Ontario Provincial Police – Business Planning Consultation

d. A breaking news bulletin was received from AMO and Frank Cowan Insurance regarding a need for municipal support on recent development s in Joint and Several Liability. Two specific proposals are under consideration: (the Saskatchewan Model) which would include a modified version of proportionate liability that applies in cases where a plantiffis

contributorily negligent. Also, under consideration is a limit on awards such that a municipality would never be liable for more than two times its proportion of damages (the Multiplier Model)

HALL/CORNELISSEN: That Council supports the proposals outlined in the letter from AMO dated February 7, 2014 and the staff be directed to forward the required letter of support.

e. Linda Creaghe, CAO advised Council that she was in receipt of a letter from Janet Johnstone on behalf of Parkhill Community Garden Project.

This was discussed at a recent Economic Development Committee meeting which is also further to a request that was received and recommended for approval by the Recreation Committee earlier this year. There was concerns regarding liability insurance and that this group is not a committee of Council. It was suggested they approach the Horticultural Society about working together on this project.

MCLINCHEY/HEMMING: That the Council of the Municipality of North Middlesex approve in principle the proposed Community Garden Project to take place at the North Middlesex Community Centre grounds.
