The Regular Meeting of the Council of the Municipality of North Middlesex was held on Wednesday February 15, 2017 in the Council Chambers, Shared Services Centre, 229 Parkhill Main Street, Parkhill with a quorum present.

1.CALL TO ORDER

Deputy Mayor Ropp opened and called the Regular Meeting to Order at 7:00 p.m. due to the presentation from the County of Middlesex by Warden Don Shipway and CAO Bill Rayburn.

6. DELEGATION

a. Warden Don Shipway and CAO Bill Rayburn - County of Middlesex updates

The presentation provided an overview on the following matters under the County of Middlesex: Quarterly Updates, Child Care, Natural Gas Expansion, Comprehensive Library Update, SWIFT, Local Services, Planning Implementation, EDCO Award, Agriculture Forum, Bridge Study, 50 King Street Update, Ontario Works, 2017 Budget, Homelessness, Strathmere Lodge Lands, Healthy Kids Community Challenge, Local Food Guides, New Visitor Maps, Tourism Symposium, SCOR, Business Profile Videos, Business Appreciation Dinner, Agricultural Tour (W. Middlesex), We are Middlesex, Affordable Housing and TVDSB Meeting.

Some questions were asked on specific topics and responded to from the Warden and CAO.

Mayor Shipway then returned to the Chair for the remainder of the meeting.

b. Ryan Chin, Co-op Student from Fanshawe College, presented an overview of work completed during his placement with the municipality during the past 8 months as well as work he is continuing to do in conjunction with the Geographical Information System or GIS project.

Several questions were asked by Council regarding the specific information and responded to by Mr. Chin. Mr. Chin was thanked for his very informative presentation.

c. North Middlesex Community Medical Centre, represented by Alice Bruce, Bob Scrimgeour and accountant Rick Hamilton, attended the meeting at the request of Council to provide financial information for this charitable organization as it is in the processing of closing. This was as a result of their request to write off the 2016 Tax Account for this entity at the last regular council meeting on February 1st.

The representatives provided council with the draft Balance and Profit & Loss Sheet at December 31, 2016 which indicates a minimal balance not sufficient to pay the required taxes. They also indicated that there are other closing out costs that will be payable.

Discussion ensued as to why the taxes were left unpaid. Municipal staff was asked to look into the credits that occurred in 2015 along with the status of \$3,800.00 that was approved during the Grants Program that the Medical Centre indicated they never received. CAO, Marsha Paley, advised Council that the reason it may not have been paid out could have been due to requirements to receive paid invoices for expenses that occurred prior to releasing funds. She will have staff look into this further.

Due to some council members being absent, it was suggested that a decision could wait until the next council meeting. The delegation was thanked for attending the meeting.

a. Report from Infrastructure and Operations – 2016 Water Annual and Summary Report

Councillor Cornelissen inquired about the treatment of catch basins. He also inquired if the GIS project will ensure that all catch basins are documented.

Mr. Graham replied that the Health Unit treats the catch basins with pellets which is part of their program, however, he will also follow up on the documentation of the catch basins in the GIS program.

Councillor Cornelissen questioned the estimate for the proposed electrical work, the generator being considered and the priority of proceeding with this work on the basis of its limited use. Deputy Mayor Ropp provided some background on why this site was being chosen for the alternate Emergency Operations Centre. He also pointed out that certain equipment is required to be on site in order for it to be considered an alternate EOC.

Mr. Graham advised that he will have staff revisit the cost and report back to council

ROPP/MCLINCHEY: That the Council of the Municipality of North Middlesex hereby supports the motion of the Prince Edward County as follows:

"Whereas the current Accommodation Review Process is not reflective of the reality of rural school and community life;

And Whereas school closures impact single school small rural communities in all educational, social and economic aspects to a far greater degree than those impacts in multi-school urban communities:

And whereas the Board of Education has initiated an unachievable timeline for the proposed transition plan and will have a negative impact on the health and safety of the students;

BE IT RESOLVED THAT the Municipality of Prince Edward County requests the Minister of Education initiate an immediate Stay of Execution on the Accommodation Review Process until such time as a review of the above mentioned impacts on small rural communities can be studied, completed and the results and recommendations be considered; and

THAT this resolution be circulated to Premier Kathleen Wynne, OMAFRA Minister Jeff Leal, MPP Todd Smith, Hastings and Prince Edward School Board, Community School Alliance, and all municipalities in Ontario"

g. Municipality of Neebing – support motion regarding Carbon Tax Credits for Municipalities

MOTION #069/2017

MCLINCHEY/ROPP: That the Council of the Municipality of North Middlesex hereby supports the motion of the Municipality of Neebing as follows:

"Whereas there are Provincial programs, including the Conservation Land Tax Incentive Program, and Provincial legislation which exempts some privately owned land parcels from all or some of the otherwise applicable municipal property taxes;

And whereas Ontario's municipalities bear the costs of these programs by having to provide services to these lands without receiving any revenue to defray the costs of those services:

And whereas Ontario is in the process of implementing a system of carbon taxes and carbon tax credits;

And whereas certain lands, such as vacant forested or cleared lands, may be eligible for carbon tax credits;

And whereas the benefit of a carbon tax credit may, at no expense to the Province, defray some or all of the costs to Ontario's municipalities for servicing tax exempt land; THEREFORE BE IT RESOLVED THAT the Corporation of the Municipality of Neebing respectfully requests the Premier, the Minister of Finance and the Legislature, when considering the policies associated with carbon taxes and carbon tax credits, to accrue any carbon tax credits applicable to tax-exempt private properties with Ontario municipalities, to the Municipality in which the land is situated, rather than to the property owner;

AND THAT this resolution be sent to the Premier, the Minister of Finance, AMO, NOMA, the Thunder Bay District Municipal League; and all Ontario Municipalities for consideration and support
