## 11. OTHER BUSINESS

a. Response to request for information pertaining to type of facility that the reserves from new infrastructure sewer rate for Ward 1 will apply.

A report was provided to council in response to how the Parkhill sewage system and the amount of reserve money needed to improve/change as development and expansion in parkhill occurs.

After some discussion on the matter the recommendation in the report was considered.

HALL/ROPP: That the Municipal Council of North Middlesex give consideration to the Water/Sewer Projects for 2013 and authorize staff to proceed with the inspections required. Staff has allocated \$150,000 for infiltration issues in the Water system and \$150,000 for infiltration in the sewage system. The above projects would help with water loss/revenue for the water department and would help with the longevity of the sewage lagoon and help reduce costs associated with treating non sewage related water.

c. Revised Water & Sewer Rates (February 19, 2013)

Finance Co-ordinator Martha Gawley provided a revised Water and Sewer Rate study which was a result of council questions from the rates contained in the last report as well as spreading the increase over the next few years opposed to all in one year. The new proposed rates will provide for the yearly operating budget, allow for a small percentage of yearly capital projects from the Capital plan and provide for the provision for the repair and replacement of the municipality's infrastructure when the need occurs. Over the next few years as the municipality moves forward with the rate study guide they will be able to eventually fund all capital projects from the infrastructure fee.

Water Rate – new proposed rate of \$1.52/cubic meter of consumed water Infrastructure fee – proposed rate of 22.48 billing period/metered unit

Sewer Rate –Ward 1 new proposed rate of \$0.66/cubic meter Infrastructure fee – proposed rate of \$58.75/billing period

Sewer Rate – Ward 2&4 new proposed rate of \$2.01/cubic meter Infrastructure fee – proposed rate of 29.25/billing period

HALL/HEMMING: That council approves the water/sewer rate study dated February 19, 2013 as provided by Hemson Consulting Ltd. Also, that staff may proceed with the completion of the Municipality of North Middlesex Water/Sewer Financial Plan based on the Hemson Rate Study as provided. That staff may proceed to prepare notification for holding a public meeting to present the proposed new rates on March 18, 2013.
