6. DELEGATION

a. 7:00 p.m. – A special Presentation by Lyndon Ashton of MDB Insight regarding the Draft Economic Development Strategy.

Mr. Ashton proceeded with his power point presentation which began with the Economic Vision for North Middlesex.

"North Middlesex is known for its diversified, export focused agricultural sector; two vibrant Downtown commercial centres underpinned by small business and entrepreneurship; and ongoing residential and employment growth supporting an increase in population and economic opportunity"

Mr. Ashton then reviewed the ways in which you know the vision is working ... by the diversification of the economy and agricultural industry; improved access to high speed internet; effective marketing and promotion of the community; a sustainable and growing small business base; increased local employment and local population; new residential development and affordable housing; support for senior populations and leveraging opportunities; youth attraction supporting increased school enrolment; available zoned, serviced and shovel ready lands; celebrating a high quality of life and an affordable place to live; supportive and efficient development administration; healthy and thriving commercial Main Streets (Downtowns); increased commercial amenities, entertainment, and lifestyle services to satisfy local consumers.

An overview of the Strength, Weakness, Opportunity and Threat analysis was then provided and explained.

The report next identified the Highest Priority Action (Immediate) to be:

- a. Build the Economic Development Capacity in North Middlesex. This could be achieved by hiring a dedicated staff person responsible for economic development services.
- b. Ensure the Community is attractive to new residents and businesses. This could be achieved with promoting assets outside of the community; promote available commercial and industrial properties; establish a database of available commercial/industrial properties in North Middlesex; consider open houses and marketing programs to promote vacant downtown locations.
- c. Market and promote North Middlesex. This could be achieved through communications and branding plan; build a promotional package for prospective developers.

Mr. Ashton concluded the presentation with an overview of other action items to consider over the next 1,3 and 5 years.

Councillor Cornelissen asked how North Middlesex compared to other communities in Middlesex County. Mr. Ashton replied the development charges are slightly higher than other municipalities in the area and location is a little further away from the large urban areas. However, he also pointed out that North Middlesex's location has other benefits such as being in a thoroughfare to tourist area destinations. He suggested focusing on what you have to offer.

Councillor Cornelissen indicated the majority of priority action items are indicative of being municipal lead projects. How does the municipality undertake all of that Mr. Ashton replied that is where an Economic Development Officer would assist under the leadership of the CAO.

Councillor McLinchey provided an update on the CFDC Main Street program which will no longer be offered as the Federal Government will not be providing funding. The program was not utilized as much as it should have been as some business owners had indicated their resources were limited and the program required matched funding from them. Also, there was cases that the businesses were tenants and not owners of the property.

Deputy Mayor Ropp advised that he agreed with the need for a dedicated staff person to keep this initiative moving. Also, that a priority should be a Developers package. He also wanted to point out that developing partnerships with other agencies such as the

ABCA should be a high priority as well. Deputy Mayor Ropp also clarified that the vibrancy funds that was mentioned cannot be just focused on Main Street projects.

The next step in the process would be to release the draft document for comment from the public as well as council. A final report will be presented to Council in March.

Mayor Shipway thanked Mr. Ashton for his presentation.
