#### 6. DELEGATIONS

7:30 p.m. – Brian Horner, General Manager of the ABCA was present to answer questions pertaining to the Proposed 2014 Budget and municipal levies.

Several questions were asked regarding the continual increases in the budget and levy to the Municipality. Mr. Horner replied that part of the increases are due to requirements from the MNR and also the special benefits needed by the particular municipality, the general budget of the ABCA is a 2% increase. The overall increase was higher last year due to the additional work that was required at the dam and Cameron Gillies Drain. Mr. Horner advised that he would provide the supporting documentation from the MNR. The budget is anticipated to be voted on by the Board of Directors at the February 20<sup>th</sup> meeting. Council expressed concern with the budget increases however thanked Mr. Horner for attending. Direction will be given to the Mayor at the next council meeting on the wishes of council for voting on the budget.

Municipality of North Middlesex Regular Meeting Minutes January 29, 2014

8:00 p.m. – Becky Tannahill, newly appointed Tourism Manager of Toursim Middlesex attended Council to provide an overview of the work done in 2013 and upcoming next steps for this year. Tourism Middlesex is the County's recognized Destination Marketing Organization (DMO) and represents Middlesex on a regional level regarding tourism development initiatives. She advised that the Information centre is located to Amy's Restaurant just south of HWY 402 in Strathroy. She advised that this presentation is being made to all the lower tier municipalities and the County of Middlesex over the next 5 weeks. They are finalizing strategies for the Tourism Middlesex Association and community enterprise for "Made in Middlesex" products, following through on committed investments by participatings with SWOTC in the Ultimate Travel Show, completing the Ontario Barn Quilt Project, participating in Cruise the Coast promotions and organizing Doors Open Middlesex 2014 volunteers. The next steps are to launch a pay to play strategy for tourism partners, Tourism Middlesex will introduce the Tourism Middlesex Association and regional advertising opportunities will also be explored. Several questions were asked by Council about this initiative. Becky was thanked for her very exciting and informative presentation and look forward to learning more about the partnering aspect of the project.
