#### 8. DELEGATIONS

# 7:00 P.M. – Clyde Walton – Nairn Road Property

Mr. Walton requested to attend the council meeting to receive assurance from the municipality about future monitoring and enforcement of this property. He expressed his opinion that he felt there was more work to be done on this property under the Tidy Yard By-law as well as enforcement under the Zoning By-law.

Mayor Shipway advised Mr. Walton that the landowner has entered into a compliance agreement with the Municipality. He was encouraged to contact the municipality should he have any concerns in the future with this property. Ms. Paley clarified that this property is zoned General Agricultural and not Rural Residential and therefore some of the compliance regulations he is referencing are not applicable to this zoning. However, the municipality is in the process of reviewing and updating by-laws which includes Property Standards and Tidy Yard. Mr. Walton then departed the meeting.

# 8:20 p.m. – OCWA – Presentation of first quarter reports for 2015

Jackie Muller, Rodney Dupuis and Marcel Misuraca from OCWA presented an overview from the following reports:

Ms. Muller advised Council that an estimate has now been prepared and forwarded to the municipality for the installation of a gas line to the Ailsa Craig Wastewater Plant for consideration. The representatives were thanked for their updates and they then departed.

# DAVIS MARTINDALE, Auditors for the Municipality

Mike Watson and Adam Dennerley were present to answer questions pertaining to the 2014 General Surplus and the proposed water rate increases. Several questions were asked and answered about the financial system. Mr. Watson also indicated that Council may want to consider amending the Water Financial Plan prepared by Hemson Consulting that was sent to the Ministry if they believe assumptions made in the plan at the time are not applicable now.

And further that Council direct staff to budget and install a list of basic rules at all public accesses to the cemeteries. As described in the By-law, a designated location with an appropriate container shall be installed at each cemetery location that clearly identifies the container as a depot for holding memorial or related items that have been removed from plots due to weather or non-compliance with the rules of the cemetery;

And further that Council direct staff following the final approval from the Ministry that a notification process be undertaken to encourage plot owners to bring their plots into compliance and that following this notification municipal staff will be directed to begin a process for identifying and removing flower beds and solar light fixtures that are not in compliance with the Cemetery By-law.
