Mr. Daigle indicated that small municipalities are defined to be with populations of less than 100,000. The municipalities in attendance at this work session indicated their preference for stable funding opportunities for budgeting purposes. He also noted that the Ministry has indicated that they want municipalities to be shareholders in this program and that other avenues of funding the project must be included. Municipalities cannot solely rely on this funding in order for a project to proceed. More information will be available later this year after all of the information sessions have been held with municipalities
