Planner Barbara Rosser advised that the application had been received and circulated according to the Planning Act.

The property which is the subject of this application was also the subject of an application for consent to the North Middlesex Committee of Adjustment (Application No. B02/2014) granted April 9, 2014 to sever approximately .3077 hectares (as modified by the Committee's conditions) from the property and retain approximately 19.5 hectares for farming purposes. The purpose of the proposed zoning by-law amendment is to amend North Middlesex Zoning By-law No. 35 of 2004, as amended, to rezone the severed parcel to Agricultural Small Lot (AG1) Zone permissive of single detached residential development. The retained parcel would be rezoned to a special General Agricultural (A1) Zone prohibitive of residential use as required by the North Middlesex Official Plan.

All written comments received were considered during the preparation of the planning report.

No public comment was received at the Public Meeting.
