The Regular Meeting of the Council of the Municipality of North Middlesex was held on Wednesday May 3, 2017 in the Council Chambers, Shared Services Centre, 229 Parkhill Main Street, Parkhill with a quorum present.

5. PUBLIC MEETINGS

7:00 PM. – Development Charges Public Meeting

Nancy Neale, Watson & Associates Economists Ltd, presented the outline for the mandatory public meeting under the *Development Charges Act*. The Background Study was prepared and available to the public on March 23, 2017. The purpose of this public meeting is to provide a review of the DC proposal and to receive public input on the proposed policies and charges. The basis for this background study is to amend the Municipality's current DC By-law to reduce the charges by 50%. The study process included Policy Review and discussions with staff; growth forecast; detailed discussions with staff regarding future needs to service growth; DC overview and new requirements as per Bill 73 presentation to staff; council workshop (January 18, 2017); background study and draft by-law released to public (March 23, 2017); notice of public meeting (April 11, 2017); public meeting (May 3, 2017) and staff report with recommendations and council consideration of By-law for adoption (June 7, 2017).

Councillor McLinchey requested clarification if rural areas paid DC Charges and if not, why?

Jonathon Graham replied that rural areas currently do not pay DC Charges. The rural areas pay for a water connection hookup charge when new development occurs and they have private septic systems.

Clerk Jackie Tiedeman advised that to date there has been no written submissions received.

Ms. Neale advised that written submissions can be received up until the time of By-law passage which is anticipated to be June 7, 2017.

No public comments were received and therefore the public meeting closed.

6. DELEGATION

8:00 p.m. – YMCA

Kathi Lomas-McGee and Kathy Willemse presented the 2nd Quarter Operations report. The highlights included: 509 members engaged. Membership Engagement: launched marketing campaign in January/February messaging personal impact stories; membership growth in families and single adults; new sales targets resulted 85% of target to date; membership is 13 favourable to budget resulting in 9% growth over previous year. Programs and Participation: Leadership programs expanded included babysitting courses with average enrollment of 17 youth; expanded group fitness classes; march break camp participation 20 children; increased enrolment with in programs such as cooking classes and gymnastics; Friday flick nights average 20 participants per week. Community Engagement: grant applications for donations and sponsorships; active volunteer recruitment commenced; community fitness challenge; volunteer awareness/recognition campaign, healthy kids day "Canada 150th " theme.

Councillor McLinchey commended the staff at the YMCA for creating a positive environment for the children and the adults.

Deputy Mayor Ropp inquired if the surplus from 2016 could offset the cost of equipment in the future. Ms. Syed responded that she would look into this further. Mr. Graham responded that capital equipment this year has been approved in the budget however it would be beneficial in future budgets.

Ms. Lomas-McGee and Ms. Willemse were both thanked for their presentation.

Ms. Syed and Mr. Graham gave an overview of the 2017 Proposed Water and Wastewater Budget. Council was reminded that water and wastewater rates have already been approved through By-law # 55 of 2015 and By-law #83 of 2015 respectively.

Councillor McLinchey requested clarification on the Parkhill Main Street water main valve replacement? Mr. Graham explained that this mainly pertains to valves on the street that are older and more difficult to open. This will be part of the ongoing new best practices program.

Councillor Moir requested clarification on the new meter reading system and whether this was for residences? Mr. Graham replied that it was an internal reading system and not individual residential meters.

Councillor Moir then inquired whether it would be more cost effective to gas line installation into the AC Treatment Plant all at once rather than over a three year phased project? Mr. Graham replied that he was contemplating this project over a three year phased in approach due to the costs. However, he would provide a staff report on both options for council consideration at an upcoming meeting.

And whereas the Township of Lake of Bays is a single public school municipality; Be It Resolved That the Township of Lake of Bays requests that Minister Mitzie Hunter, Minister of Education initiate an immediate moratorium on the Accommodation Review Process until such time as a review of the above mentioned impacts on small rural communities can be studied, completed and the results and recommendations considered;

And further that this resolution be circulated to Premier Kathleen Wynne, MP Tony Clement, MPP Norm Miller, Trillium Lakeland District School Board and all municipalities in Ontario."
