## 6. DELEGATIONS - 7:30 p.m. Middlesex Wind Action Group

Muriel Allingham, spokesperson, attended Council along with several citizens to request from Council how the municipality is addressing the communities concerns pertaining to the IWT Project that was recently given approval. These concerns range from how fire response would be handled, health concerns,

property devaluation, stray voltage, ice, shadow flicker, lighting. Legal costs to address this should be viewed as an investment in the community. Several documents were also provided to Council and were included within the agenda. This also included written correspondence submitted over the last couple of weeks from individual citizens.

Municipal Solicitor, John Kennedy, responded and agreed that these were valid concerns, however, the powers to address some of these concerns pertain to different levels of government. The by-laws that other municipalities are trying to implement are being challenged because they are beyond the municipal jurisdiction. He advised that Health and Safety and Property Standards are by-laws the municipality can explore and work in conjunction with the wind companies to avoid litigation. He agreed that the recent REA has little regard for the municipality's concerns. He is suggesting to Council that although the appeal is very limited and pertains to environmental concerns only, it still warrants putting forth an appeal and it was also suggested that the municipality retain Solicitor Eric Gillespie for this specific task due to his expertise in this particular area.

Mr. Kennedy stated that the municipality is taking all the concerns raised by the public and by council into account and making provision for this within the draft agreement with Nextera of which he provided the table of contents.

Mr. Kennedy then commented on the request for a motion from council which would indicate the municipality is "not willing hosts for IWT's projects". Other municipalities were provided this same request and will hopefully follow this lead.

Mr. Kennedy was then requested to respond to some specific concerns raised in a letter from a citizen. Mr. Kennedy advised that the municipality is not responsible for regulating property values. This is a provincial matter. There is no requirement to protect residents from lawsuits due to IWT's, this is between neighbours, not the municipality. With respect to buying and selling property, he advised that a statement of disclosure is the responsibility of the real estate agent as well as with the vendor (ie: wind leases on their property) and in turn, a potential purchaser should ask for a disclosure statement. This pertains to the specific property being sold or purchased. There is no obligation to disclose what may or may not be happening on a neighbours property.

Mr. Kennedy also advised Council that in his opinion the time has come that Council should consider hiring a compliance consultant for the IWT project. He felt this could be accomplished by a part-time contract position for this specific project. This project is beyond what can be expected of current staff to manage in addition to their regular duties.

Following this discussion and based upon advice from the solicitor, the following motions were then considered by Council.

MOIR/HALL: That Council direct our Solicitor to retain the services of Eric Gillespie for the purpose of forwarding a Notice of Appeal to the Environmental Tribunal due to the lack of regard for health of humans and animals in the REA decision and that a preliminary disclosure be prepared.

**CARRIED** 

**CORNELISSEN/MCLINCHEY**: WHEREAS the Premier of Ontario has recently conveyed the Governments desire to limit Industrial Wind Turbine (IWT) Projects to communities that are willing hosts;

AND WHEREAS Council for the Municipality of North Middlesex has received a clear message from its residents that they are not willing to host IWTs in North Middlesex;

AND WHEREAS Council for the Municipality of North Middlesex applauds the position taken by the Premier and the Government;

AND WHEREAS Council represents all citizens within the Municipality, both those in favour of wind projects and those opposed. As a result, Council needs to maintain a fair and balanced viewpoint;

AND WHEREAS council is very concerned that the Green Energy Act has substantially changed the rules for municipalities with respect to wind farm developments by removing municipal control over development applications through the traditional zoning requirements under the planning act approvals for wind project developments are now controlled by the Ministry of Environment through the Renewable Energy Approval process, a legislative development that the council strongly opposes;

AND WHEREAS Section 41 of the Electricity Act requires that a municipality provide to wind project developers without charge access to and use of its road for both construction and maintenance of its turbines and electrical infrastructure, including transmission lines;

AND WHEREAS future jobs of Ontario are going to hinge on efficient energy costs, by subsidizing the cost of energy by these wind projects, we are limiting the future growth of Ontario;

THEREFORE based on the consistent position of Council for the Municipality of North Middlesex and the input received from the community regarding IWT's, the Province of Ontario and specifically the Ministry of Environment be now advised that the Municipality of North Middlesex is "NOT A WILLING HOST" for IWT's;

AND THAT this resolution be circulated to Premier Kathleen Wynne, as well as to the Minister of Environment, Minister of Energy, Minister of Rural Affairs and to all Ontario municipalities for their support and endorsement.
