And further that staff be given approval to hire Murray McLean Auctions to conduct an auction at the former Municipal Offices on Saturday November 29, 2014 and that all remaining items from the former Municipal Offices be included in the auction, including railings. Doors, baseboards, exterior architectural fragments etc.

And further that proof of liability insurance must be provided by members of the public to the Municipality prior to removal of any building components;

And further that any items located in other facilities and considered non-essential, as determined by staff, can be placed in the auction sale with an inventory list to be provided to Council prior to publication to the public;

And further that following the November 29<sup>th</sup> on site auction any remaining fixtures or items not sold can be disposed of by staff on behalf of the municipality or included in the Request for Proposal prior to demolishment of the former municipal offices building.
