11.OTHER AND URGENT BUSINESS

a. Deferred from September 19 – QPA request to sign Confirmation of Option Expiry for three rooftop solar projects, Deputy CAO Jonathon Graham (Verbal Update)

Mr. Graham advised that further to the last council meeting, he will be providing a separate report on the revenue received from these solar projects, however, in the meantime, the opportunity to purchase the rooftop equipment at the end of the lease has expired and therefore he was seeking approval from Council for the Mayor and Clerk to proceed with signing the required paperwork as requested by QPA. The municipal lawyer concurs with this request.

b. CAO, Nandini Syed, verbal report on AMO Policy Update – Province to introduce Private Cannabis Retail Legislation – with Municipal Opt Out

Ms. Syed provided a verbal update on this new legislation that would authorize the Alcohol and Gaming Committee of Ontario to licence private cannabis stores in Ontario Municipalities. It was clarified that if Council not does provide feedback on its intent to allow these retail stores then North Middlesex would by default "Opt In".

If North Middlesex Council choses to "Opt Out" by the deadline of January 22, 2019, councils can still opt in at a later, to be stated, date. All municipal governments will receive at least the \$10,000 to support transition to legal cannabis and the province will announce the full funding allocation in the future.

Due to timing with the municipal election and the newly elected Council that takes office on December 1st, 2018, she was looking for direction as to how Council wanted to proceed with consideration of the "Opting Out" option.

Planner, Stephanie Poirier, also updated Council on her involvement at the County insofar as collection of information for her report at County Council which will be shared with the lower tier municipalities in the next couple of weeks.

After considerable discussion, council concurred that this should be a decision of the new Council. Council also felt it was important to have public input into this decision.

Staff expressed concern with how the public consultation would take place due to timing constraints from the election, upcoming Christmas break as well as the January 22 deadline. Further consideration as to the extent of public consultation and how Council would like this done should be decided soon.

12. COMMUNICATIONS (including County Council Meeting Updates)

Deputy Mayor Ropp advised that the County Council October meeting has been cancelled due to lack of business.

Councillor Moir requested more information regarding the fibre optic line going down McGillvray Drive.

Mr. Graham responded that staff was recently made of aware of this as well through the road allowance work permit process and is looking into it further. He will be preparing a report to Council on options available to the municipality to let residents known when they are made aware of these types of projects in their area. He advised that as this information is through a 3rd Party that there is privacy protocols that need to be taken into consideration and how, if any, information can be released to the public.

Deputy Mayor Ropp and Councillor Moir both expressed concern that there is a lack a communication when projects such as this are brought into North Middlesex and that the residents that could possibly benefit from tapping into the line are not contacted.

Mr. Graham agreed and this report would outline available options to hopefully address this moving forward.
