Additional Item: Clerk, Jackie Tiedeman, advised Council that QPA Solar had approached the municipality regarding a FIT application they are sending preparing for a ground mount project at 35573 Salem Road. A Land use restriction exemption resolution is required from the Municipality as part of the Fit Rules, Version 4.0.

**MOIR/ROPP:** Project Sunrise LP (the applicant) proposes to construct and operate a non-rooftop Solar Project (the Project) on 35573 Salem Rd., Parkhill, Ontario NOM 2K0 (the lands) in the Municipality of North Middlesex under the province's FIT program;

And whereas the Applicant has requested that the Council of the Municipality of North Middlesex indicate by resolution that the Project has an exemption from any or all of the

residential, commercial and industrial land-use restrictions as identified in Sections 2.3€, 2.3 (f), 2.3 (g) and 2.3(h) of the FIT Rules, Version 4.0

Now Therefore Be It Resolved That the Council of the Municipality of North Middlesex exempts the Project on the Lands as described above from any or all of the residential, commercial and industrial land-use restrictions as identified in Sections 2.3(e), 2.3 (f), 2.3 (g) and 2.3(h) in the FIT Rules, Version 4.0
