11. OTHER BUSINESS

a) August 12, 2015 – Tabled for additional information – Water Rates

Acting Treasurer, Deb Jonah, provided an update on requested information regarding the proposed water rate increases. Councillor Cornelissen indicated that the concern was for all large waters users, which includes the agricultural sector. Councillor Hemming reminded Council that the City of London, from which we purchase the water, has imposed a 5% increase annually. After some discussion, council directed Ms. Jonah to explore the possibility of a discounted rate, on consumption only, over 2,000 cubic metres per billing period (3 months). A report with recommendation on a proposed rate for consumption and the fixed rate for infrastructure is to be available for September 16th with an implementation date of January 1, 2016. In addition, the rate charged to neighbouring municipalities that purchase water from North Middlesex is to be reviewed to ensure our expenses are being recouped accordingly.
